- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.
- E) Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik, the Second Party is engaged in Business, Manufacturing, Skill Development, Education and R&D Services in the fields of Sericulture and related fields.
- F) Give related information, its branches, and dimensional information about the industry concerned with which the MoU is sworn.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:**



## **CLAUSE 1 CO-OPERATION**

**Arts, Science and Commerce College, Cidco, Nashik & Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik** are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Arts, Science and Commerce College, Cideo, Nashik** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

**Arts, Science and Commerce College, Cidco, Nashik & Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik** co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.

The general terms of co-operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. **Curriculum Design:** **Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik** will give valuable inputs to the **Arts, Science and Commerce College, Cidco, Nashik** in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

**CLAUSE 4  
VALIDITY**

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik**, the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of **Training Partner or Maratha Vidya Prasarak Samaj's Karmayogi Dulaji Sitaram Patil Krushi College of Agriculture Nashik**, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MoU

Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations

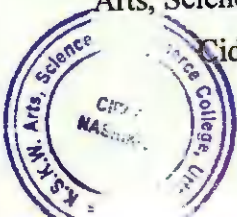
**CLAUSE 5

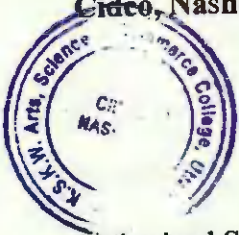
